PASSENGER SERVICE FEES REGULATIONS, 2020

Regulations made by the Governor in Council under section 86 (3) (l) of the Anguilla Air and Sea Ports Authority Act R.S.A. c. A57.

Interpretation

1. In this Act—

“AASPA” means the Anguilla Air and Sea Ports Authority;

“Court” means the High Court;

“Passenger Service Fees” means the charge imposed by section 2;

“passenger” means a person who proposes to travel from Anguilla to any place outside Anguilla, whether by air or by sea.

Charge of Passenger Service Fees

2. (1) Every passenger who leaves Anguilla, whether by air or by sea and goes to any place outside Anguilla shall, on each occasion, pay to the AASPA such fees hereinafter called the “Passenger Service Fee” in accordance with this section.

(2) The Passenger Service Fees payable by each passenger is specified in the Schedule.

(3) Notwithstanding subsection (1), the following passengers shall be exempted from the payment of the Passenger Service Fees—

- (a) the captain and crew of aircraft and vessels leaving Anguilla;
- (b) in transit passengers and passengers who have remained in Anguilla for less than 12 hours and leave by air;
- (c) Heads of State and persons travelling on diplomatic passports;
- (d) passengers in possession of exemption certificates issued by the AASPA.

Duty of AASPA to collect Passenger Service Fees

3. The Passenger Service Fees shall be collected by the AASPA before the passenger embarks the aircraft or vessel.

Enforcing payment of Passenger Service Fees

4. Where any Passenger Service Fees required to be paid under section 2 are not so paid, the AASPA may direct the Comptroller of Customs to withhold clearance of the aircraft or vessel transporting the passengers in respect of whom the Passenger Service Fees are payable.

Offences

5. (1) Any person who makes any false statement or false representation for the purpose of evading the payment by himself or by any other person of the Passenger Service Fees is guilty of an offence and is liable on summary conviction to a fine of \$5,000 or to imprisonment for a term of 6 months.

(2) In addition to any penalty which may be imposed under the provisions of this Act, the Magistrate may order the payment to the AASPA of any Passenger Service Fees due and payable and may order, in default of such payment, imprisonment for a period of 6 months.

Citation and Commencement

6. This Act may be cited as the Passenger Service Fees Regulations, 2020 and shall come into force on 8th May 2020.
